



Health, Safety and Environment Information & instructions for visitors



Visitors entering the premises of Knorr-Bremse Palwal must observe prevailing laws and regulations concerning data, property security, environmental protection, fire protection, health and work safety.

This information leaflet summarizes safety rules and information that partners, and visitors need to know. If you have any question, please contact the security service or Health Safety and Environment staff.





SECURITY SERVICE, PERSONNEL AND VEHICLE CONTROL

The security service is responsible for coordination and control tasks. The security services are bound to check the presence and validity of entry passes, hand baggage of leaving persons and passenger and load compartment of vehicles. They also carry out random checking of people at the plant and the order of transport and parking.

ENTRANCE

Entrance into the plant is allowed with a Visitor pass only. It applies both to pedestrian and vehicle entries.

After recording personal data, the security service gives you an identification card labelled "Visitor" which must be worn while you are in the plant area.

It is strictly prohibited to enter the shop floor without being escorted by company's representative.

VEHICULAR/ PEDESTRIAN MOVEMENT

The **speed limit for vehicle movement is max. 20km/hour** and visitors are required to park the Vehicle in designated area.

Pedestrian to use walkway only.

In case of no walkway, please use side of the road and walk carefully.

SMOKING

Our endeavor is to promote tobacco free environment. Smoking and chewing tobacco inside the plant is strictly prohibited. Smoking is allowed only at the designated area.

DATA SECURITY

Taking photos and video recording is strictly prohibited within premises.

Any person found taking out any data without permission of management, the company may take legal actions against the person.





HEALTH AND WORK SAFETY

Suppliers and partner companies are responsible for ensuring that their employees and work equipment meet all health and safety requirements.

Entry to the plant premises is only by the authorization and under supervision of the hosts.

Wearing personal protective equipment depends on the particular work process. For information, contact the relevant manager.

In case of emergency, visitors have to leave the building together with employees at the nearest emergency exit, wait at the Assembly point and carry out the instructions given.

REPORTING OBLIGATION

Every person in the plant including visitor is bound to **report all** detected accidents, fire or environmental damages.

ENVIRONMENTAL PROTECTION

Environmental protection is a highly important area for KB-Palwal, and therefore, apart from other environmental investments, selective waste collection has also been introduced in the shop floor. The company expects all its visitors to help avoid unnecessary environmental load.

IT IS FORBIDDEN TO CARRY.:

- alcoholic beverages or substances,
- objects classified by law a weapon,
- media objects, publications, pictures, etc. suitable for stirring up hatred against the India Republic or another country, nation, ethnic or religious groups, races, and that infringe general human values, public morals, public decency, or human rights,
- live animals and other veterinary restricted products.

Cameras, video-cameras, or electronic data medium are allowed to be carried only with a permission.
